

Fordham Sponsorship Annual Report Released



As a charter school sponsor (authorizer), Fordham submits an accountability report to the Ohio Department of Education at the end of November each year. The report includes profiles of each Fordham-sponsored school, as well as graphics comparing the achievement data of our schools, their home districts, and statewide averages. You'll also find pertinent information on Ohio charter school spending over the last decade, and in the introduction, a timely analysis of the political and legislative environment impacting Ohio charters in 2008-09 that explains why the title, "Seeking Quality in the Face of Adversity," is befitting. Available Grants

General Grant Program

The Ohio Environmental Education Fund (OEEF) offers grants for environmental education projects in excess of \$1 million annually. These highly competitive grants are awarded in amounts of up to \$50,000 each.

There are two grant cycles annually; deadlines are January 15 and July 15. Educational projects that target pre-school through university, regulated community, and general public audiences are eligible for funding under the general grant program. Grant guidelines are available that detail application requirements and preferred characteristics of all grant proposals. Grants coordinators are also available to assist in preparing grant proposals prior to the deadline dates.

Mini Grant Program

OEEF began the Mini Grant Program, in 1999. Mini grants are available for projects requesting a minimum of \$500 and a maximum of \$5,000, with a project period up to 12 months. The program addresses proposals requesting funding for specific classroom and workshop projects, conference speakers, and other items/activities that are eligible under the General Grant Program. Application forms, reviews, and reporting requirements are streamlined, compared to the General Grant Program. Ohio EPA's Office of Environmental Education has set aside up to \$50,000 each grant round, or \$100,000 each year, to fund smaller projects under this program. As with all funding requests, the final decision will be made by the Ohio EPA director.

2009 School Team Nutrition Mini-Grants

The Office for Safety, Health and Nutrition (OSHN) of the Ohio Department of Education (ODE) is requesting proposals from Ohio elementary schools to apply for a \$2,000 mini-grant to host an ODE-developed Parent Academy on nutrition entitled Power Up Moves and Food. Elementary schools receiving mini-grants will be required to send one facilitator to a two-hour workshop focusing on how to host a Parent Academy in their schools and communities.
