The spring site visits will be structured similarly to the fall visits (i.e., one full day that encompasses a student records review, special education records review, classroom observations, and interviews with the school leader and staff).

The U. S. Department of Education recently advised us that any charter school offering Supplemental Education Services (as required per No Child Left Behind) must ensure that all SES providers are in full compliance with all state transportation laws and rules, if the SES provider transports any students. This directive applies even if the school does not own or operate any of the vehicles used to transport the students participating in SES.



Are Bad Schools Immortal?

This study from the Thomas B. Fordham Institute finds that low-performing public schools—both charter and traditional district schools—are stubbornly resistant to significant change. After identifying more than 2,000 low-performing charter and district schools across ten states, analyst David Stuit tracked them from 2003-04 through 2008-09 to determine how many were turned around, shut down, or remained low-performing. Results were



generally dismal. Seventy-two percent of the original low-performing charters remained in operation—and remained low-performing—five years later. So did 80 percent of district schools. Read on to learn more—including results from the ten states.

Come February 1, 2011, the Office of Exceptional Children (OEC) will be relying on information found in OEDS to create a special education contact list. As such, OEC is asking that every Local Education Agency (LEA – charter schools are their own LEAs in Ohio) supply them with a special education contact.
